**BASIC INGROUND OPENING** (20 x 40 or smaller)----- \$ **365.00** ☆

- Remove cover, wash and fold. ☆
- Clean coping, tiles and skimmers.
- Re-install deck equipment, pump, filter and fittings.
- Hose off deck, start system and test water.

☆ **Automatic covers are cleaned and hosed off.**

☆ There will be extra labor and material charges for clean-up of pools with heavy debris & green water.

**ACID WASH WITH BASIC OPENING** ----- \$ **899.00**

- Empty swimming pool.
  - Pressure wash interior.
  - Brush walls and floor with acid.
  - Return when pool is filled to complete basic opening.
- NOTE:** Swim Clean, Inc. is not responsible for the disposal of pool water when a large enough drywell is not available. Customer must arrange a location to empty pool. Emptying water into street is illegal in NY State.

**BASIC ABOVE GROUND OPENING** (15 x 30 or smaller) ----- \$ **250.00** ☆

- Remove cover, wash and fold. (With water bags... + \$50.00)
- Clean top railing, ladder and skimmer.
- Re-install pump, filter and fittings.
- Check over all filter system hoses of hoses are an additional charge (replacement)
- Hose off deck around pool, start system and test water.

**SELF-CONTAINED SPA OPENING** (10 x 15 or smaller)----- \$ **250.00** ☆

- Remove cover, wash and fold.
- Empty spa.
- Wash down spa interior.
- Re-install deck equipment, pump, and filters (up to three of each)
- Fill spa, start system and test water.

☆ **There will be extra labor and material charges for clean-up of spas with heavy debris &/or staining on the spa surface or excessive water on the cover.**

- Initial shock treatment (per 4 gallon treatment) .....\$ **25.00**
- Each additional pump, filter and auto-vac system on line .....\$ **35.00**
- Dismantle and hose filter elements (Acid wash elements priced upon request) .....\$ **75.00**

When a drywell is not available, customers should drain the water from the cover prior to the pool opening with a slow pump. This will prevent the flooding of yours and neighbor's property. If Swim Clean, Inc. is to empty the cover of water or drain the pool, you the customer must provide the location for the disposal of water. Swim Clean, Inc. can not be held liable for any damage from the disposal of this water.
  
- 2.) **Please allow 7 to 10 days from opening to intended day of use.** Most openings are not completed on the same day and may require several return visits. **NO OPENINGS SUNDAY !!! SATURDAY OPENINGS 10% UPCHARGE !!!**
  
- 3.) **Openings will not be scheduled without a signed contract and deposit.** Please mail your signed contracts along with a deposit of **\$200.00 for pools. For credit card deposits or payments see below.**
